Board of Directors Meeting September 14, 2021

ELECTION RESULTS

There were 22 ballots returned via mail. Guests Sandra Piseño, Albert Shaw along with Lori Acuña tallied the ballots and presented the results. Albert nor Lori were up for re-election. The results were as follows:

Destiny O'Kane 18 votes

Mary Sandoval 18 votes

Linda Davis 17 votes

Albert Shaw 17 votes

Denise Herndon 22 votes

Robert Piseño 16 votes

There were three "write-in" votes with one vote each: Clarissa Lange, Wendell Ogletree, and Raoul Olson.

There were five vacancies to be seated on the board. This led to a discussion that two of the people elected were not even at the meeting and that Ms. O 'Kane's work schedule would prevent her from attending meetings and Ms. Sandoval probably did not even want to serve, therefore Mr. Piseño should be placed on the board. It was mentioned by several that the two ladies in question should be notified and asked if they were intending to serve on the board. After a heated discussion suggesting that Ms. Bailey resign to make room for Mr. Piseño to serve on the board. Denise Herndon nominated Robert Piseño not only be placed on the board but nominated him as President even though he had the least number of votes. Leslie and Linda encouraged Toni to not resign until the ladies were at least spoken to.

REVIEW OF MEETING MINUTES

The price of borrowing money is very low right now. Toni stated that she would look into loans but was not optimistic as there is nothing to put up for collateral.

 - 5. <u>GROUNDS/LANDSCAPING:</u> Linda stated that she had spoken to the gardener about the schedule, and he will be starting on the shrubs now that the watering and mowing is slowing down.
 - 6. <u>RECREATION:</u> After some discussion that the weather is getting better and COVID is slowing down we need to get together. It was suggested that we have another potluck breakfast. All agreed we are running out of time to have another movie night. The decision was made to have that on October 16th. The general idea was to have a G rated "scary movie!" The last thing that came up was to get a lead on a Christmas party. The date for that is scheduled for December 18th at the golf club. Toni stated that she would go over and make that reservation.
